### **Public Speaker**

- -Marianne Milton, representing the Wilkinson's Memorial Book Station, spoke requesting financial help from the Town. The American Legion, who owns the property that the Library is housed, has requested they vacate the building by December 31, 2021.
- -Lawyer, Joe Wilkinson, dedicated the Library in 1980 and passed in 1991. In 1999 the building was sold to the American Legion where the Library has remained free of rent until the end of this year, where they must find a new location.
- -Marianne Milton stated she would like the Town to establish a public library by raising taxes, if need be, or to provide a building to house the Library. She thanked the Town for the \$2,000 in support they received from the Town each year but stated it is just not enough to sustain the Library now that they need to find a new home, requesting at least \$100,000. Marianne also stated she sees no reason why the Town can't give \$20,000 to \$30,000 a year to maintain a Town Library, after spending so much on the Town Park.
- -Marianne stated there is a computer for the public to use at the Library, it serves @1200 people a year with book sales and knitting groups prior to COVID.
- -The American Legion offered 57 North St. next to the Methodist Church but that was declined by the Board of the Library. Also declined by the Board of the Library was a house at 141 Midline Rd. offered by Councilman Kissinger.
- -Supervisor Perry stated we serve the taxpayers of this Town and any such tax increase of this magnitude should be placed on a referendum on the ballot of the General Election in November, to see how the public responds.

- -Other suggestions were to contact the County to see if any housing is available through perhaps foreclosures or financial assistance. Supervisor Perry also inquired if the old Post Office Building is available or any stores on Main St. Marianne will investigate those suggestions and will continue working towards establishing the Library as a Public Library, instead of staying as a 501C3 non-for -profit, for further financial assistance from the State.
- -Supervisor Perry thanked Marianne for presenting this evening stating we will wait to hear from her again on how to proceed whether she finds a place or to place a referendum on the November ballot.

- -Supervisor Perry read aloud a letter in response to his inquiry written by the Town Clerk.

On April 16, 2021 Town Supervisor Perry had a telephone conference with Donald Boyajian, Attorney for the DEC. They will be speaking again soon. Since negotiations are pending, both sides are presently unable to share specifics. One thing Supervisor Perry will let you know is that she has asked that the User Agreement to operate in the next two years, be left in place. ### Supervisor Communications cont.

- -Supervisor Perry stated the DEC is planning major changes up at the boat launch which would alleviate the parking situation on Lakeview Rd.
- -The Board Members have a copy of the Highway Employees Teamsters Contract to review, which comes due in the beginning of 2022. Negotiations are not taking place as of yet.

### County News

- -COVID update is as follows: As of May 10, 2021 there have been 4,239 positive cases in Fulton County, 57 active cases, 4,082 recovered, 9 currently hospitalized, 100 deaths to date, 101,351 people tested, resulting in a daily average at this time of @2%.
- -In a month from now vaccinations will no longer be given in pods, they will be made available in pharmacies or private health providers. The County is trying to get mobile units to administer vaccinations at the schools with the Pfizer vaccine which requires Super-cold freezers, which will need to be attained.
- -Supervisor Perry stated the Fulton County Solid Hazardous Waste drop off day will be held on August 7, 2021 from 7am to noon at Mud Rd. Also there will be latex paint exchange every Saturday morning June 5 through August 28, 7:30 am 11:30 am at Mud Rd.
- -Supervisor Perry explained the current overview of the Marijuana Regulation and Taxation Act.

On March 29, 2021 legislative leaders and Gov. Cuomo announced and printed a final three-way deal to legalize adult use cannabis and create a consolidated Office of Cannabis management (OCM) within the State Liquor Authority. Which means towns will be looking at approving operations within their towns in the near future.

-Sheriff Giardino sought permission to contract with the Town of Perth and the Perth Town Court for the services of a Deputy Sheriff during court proceedings. Sheriff Giardino stated that they currently contract with the Town of Johnstown to provide the same type of security during court proceedings. He stated it could be a part-time deputy or a deputy that wants additional overtime, estimating the cost to the Town @\$4,000.00 per year, to be paid on a quarterly basis.

-Councilman Bardascini stated he would like to investigate further before a decision can be made.

-Supervisor Perry read a letter from the Planning Board recommending that the Town Board consider appointing Michael DePaula of 131 Betor Rd. to the vacant seat on the Planning Board. Mr. DePaula has attended several meetings of the Planning Board in the past and they feel as though he would be a great asset to the Board. He has owned property in Broadalbin for 40 years and in business for himself for that long. He also has experience in the building field, built 2 homes for himself and family and is currently the President of the Betor Rd. Group, developed for the purpose of paving and preserving the road.

On a motion made by Councilman Bardascini and seconded by Councilman Kissinger The Town of Broadalbin Town Board has hereby approved the appointment of Michael DePaula as a Planning Board Member effective immediately compensation rate of \$150 paid quarterly on payroll.

Discussion- Councilman Bogardus stated he believes there should be an alternate too.

### Assessing

-Laurie Bollock stated due to COVID there are some changes this year to Grievance Day. -Dale Potts stated he has passed the recent inspection from NYS Ag & markets. There were 8 dog calls, 3 bites, 2 at large, 1 barking dog, 1 family of woodchucks under someone's porch, and a call about chickens in their yard.

-Eric Alley stated he will have to update the 284 form since good news from the Governor who has restored the Winter Recovery Fund and the Pave NY Fund. The money for the Town of Broadalbin paving for 2021 is \$350,842.52, which will be amended and sent with the original signed 284 form.

### Planning Board

- -Chairman Mike Crispin stated at their April 28, 2021 Planning Board Meeting the Board recommended Mike DePaula as a new member.
- The Planning Board gave a conditional approval of the Ballou Whiskey Distillery on the corner of Saratoga Ave. and Route 29 pending a NYS DOT Access Entryway from Route 29. SEQR completed with no environmental impact.
- -A lot line adjustment is being considered on County Highway 110, just waiting on paperwork to be completed by the resident.
- -A site plan review is being considered for an RV Park in the back of Mike Bogden's property at 626 Union Mills Rd. consisting of 26 spots on 100 acres far back from the road with APA involvement. Town Attorney Carm Greco not present

### Town Park/BYC

- -Keith Buchanan stated on May 1, 2021 the Town Park had a soft opening with all the fields being used along with the public walking around and playing on the basketball courts. The Grand Opening will be closer to the first weekend in October of 2021.
- -Collins Turf will be fertilizing next week for the first time this season.
- -Fundraisers coming up are the Junk in the Trunk with a Brooks BBQ in July along with the Home Show/Craft Fair and Brooks BBQ scheduled possibly for November 2021.

- -Keith inquired if they can use the metal garbage cans once used at the beach. The Board stated as long as they can be secured in some way so can't be stolen the Park may borrow them.
- -Supervisor Perry will contact our NYMIR Risk Management

Representative to inquire about any further signage needed near the entrance of the Town Park.

- -Keith stated there will be three dog stations along with two (2) small tool sheds for easier access. Donation from Home Depot for the sheds will be investigated.
- -The final Occupancy and Maintenance Agreement with the School and BYC has been signed.
- -Also discussed was the possible need for signage stating this is a "gun free zone" for the Park, which will be investigated.
